

HAROLD E. EISENBERG FOUNDATION REAL ESTATE CHALLENGE WINNERS

The Harold E. Eisenberg Foundation Real Estate Challenge was designed to provide students with a hands-on opportunity to apply what they are learning in their university courses to the real working world of real estate. Each team is paired with volunteer advisors, all of whom are leading Chicago real estate professionals. The student teams are challenged to create a development plan for a particular site. The teams, along with their advisors, determine what should be built on the property and provide a full analysis explaining their building plan as well as the effects their plan would have on the community.

The winning plan is the most economically viable and most complementary to the unique uses of the surrounding site. The teams' presentations are judged by a panel of professionals. The Harold E. Eisenberg Foundation presents a scholarship (of up to \$5,000) to the winning team's school.

PAST CHALLENGES:

2020 | The 2020 Challenge subject site was a 7.9 acre site on Moody Bible Institute's campus. Located in the Near North Side of Chicago, the case site included a string of outer-lying properties roughly bounded by Chestnut Street, Wells Street, Oak Street and Franklin Street. Each teams' proposal outlined a conceptual site plan showing how Moody Bible Institute could transition the site into a destination location connected to the surrounding neighborhood.

The winning team from DePaul University was comprised of Vincent Casambre, Alexander Hernandez, Greg McClellan, and Mark Solak with Steve Bell as their advisor. 2019 | The 2019 Challenge subject site was an 11.7 acre site attached to the Chicago Ridge Mall ("Challenge Site"). The parcel contained a 154,000 square foot department store box, formerly occupied by Carson's. The site was an enclosed single-level super regional center located in a high-density trade area. Major roads include access to I-294 and US Highways 12/20.

The winning Graduate Division team from University of Illinois at Urbana-Champaign was comprised of Art Konotopskiy, David E. Mischiu, Patrick Page, and Harsh Tiwari with Roger Cannaday, Sophie Sianis, and Alexei Tchistyi, as their advisor. Ridge North was their winning proposal. Watch their live presentation HERE.

2018 | The 2018 Challenge focused on a pair of parcels totaling 11 acres located on the shore of Lake Michigan in Waukegan, IL. Once the core of the community's renowned commercial base, the sites were vacant and awaiting a transformative redevelopment. The challenge sites were situated roughly a quarter mile from Downtown.

The winning Graduate Division team from University of Illinois at Urbana-Champaign was comprised of Bradley Berg, Jen Concepcion, Kristopher Kobernus, Rebecca Palmer, Jesse Thomas, and Logan Walker with Roger Cannaday. 2017 | The 2017 Challenge focused on a parcel of City of Chicago and Imperial Realty Company-owned land that was formerly the home of the U.S. Sixth Army Headquarters and Quartermaster Depot and the headquarters of Chicago Public Schools, in the historic Central Manufacturing District. Each team acted as a separate development company responding to a Request for Proposal from the City of Chicago and Imperial Realty Company to purchase the site and to redevelop it into a dynamic project.

The winning team from Roosevelt University was comprised of Iryna Auchynnikava, Joseph Copak, Gedeon Dansou, Michael Kritzman, Rose McKeon, Robin Schabes. Ken Marino served as their team advisor. Their winning presentation, titled The Innova District, incorporated arts, agriculture, technology, and transportation with service, retail and commercial outlets in order to revitalize the area. The proposed project was independently produced as part of the Real Estate Challenge and does not represent the views of the City of Chicago or Imperial Realty Company.

2016 | The 2016 Challenge focused on the approximately 7.4 acres of City-owned land that was formerly the home of Englewood Mall, bordered by 63rd Street to the south, Halsted Street to the east and Halsted Parkway to the north and west. Teams were asked to respond to a Request for Proposal from the City of Chicago to form a joint venture and redevelop a dynamic project on the former Englewood Mall Site. The City looked for teams to submit proposals that were both realistic but also metamorphic for the area in the years to come. The winning team from the University of Illinois at Urbana-Champaign (UIUC) was comprised of team leader, Ben Skinner, and members, Ines Andrade, Nick Bartholomew, Eliseo Elizarrarez, Ryan Hamerick, and Austin Pye. UICU faculty and industry advisors included Roger Cannaday, Peter Caruso, Jim Kurtzweil, and Steve Leonard.

UIUC's winning proposal, <u>Station at 63rd</u>, incorporated diverse retail offerings, an abundance of community space, and numerous mixed-income residential units. Please note that the proposed project was independently produced as part of the HEEF case competition and does not represent the views of the City of Chicago.

2015 | The 2015 Challenge focused on the "Cap the Kennedy" Project over the Kennedy Expressway (I-90/94) between Lake Street and Jackson Boulevard in Chicago, Illinois, a project proposed by Fifield Companies in an effort to establish a more functional connection from Chicago's West Loop neighborhood to the downtown Loop/Central Business District. The winning team from Roosevelt University was comprised of five graduate students, Mary Fran Gill, Hubie Greenwald, Daniel Gutman, Karli Mayher, and Ainsworth Thompson. Roosevelt faculty and student advisors were Dennis Harder, Jon DeVries, Johnathan Dennis, Aaron Pavitt, Scott Goldman, and Ken Marino. The panel of judges included Steve Fifield, Randy Fifield, Mike Laube, and Alan Schachtman. This marked Roosevelt University's third year in a row winning the case competition.

2014 | The 2014 Real Estate Challenge focused on the former Marshall Fields/Macy's Warehouse at 4000 W. Diversey just northwest of downtown Chicago. The competition and was won by the team from Roosevelt University, comprised of students Andre Collins, Maggie Eison, Victor Fragoso, Liliana Gonzalez, Dion Hickles, Emmanuel Kinard, Andrew Savoy, Eric Williams. University of Notre Dame and Marquette University tied as runners-up. 2013 | The 2013 Real Estate Challenge focused on Sears Holding's 33-acre site at 62nd and Western Avenue in the Marquette Gardens/Chicago Lawn neighborhood on Chicago's south side. 2011 The 2011 Real Estate Challenge focused on the former Cabrini-Green public housing projects in Chicago and was won by the team from University of Illinois at Urbana-Champaign, comprised of students Matt Lesh, Kyle Pietila, Briana Dunne, Connor Matthews, Cheng Wang, Jenna Goebig and Taylor Douell.
